2012 Annual Drinking Water Quality Report For the City of Whitefish Water Utility

We are pleased to present to you this year's Annual Water Quality Report. This report is designed to inform you about the quality water and services we deliver to you every day. Our constant goal is to provide you with a safe and dependable supply of drinking water. We want you to be informed of the efforts we make to continually improve the water treatment process and protect our water resources. We are committed to ensuring the quality of your water.

Our water source is surface water collected from the Haskill Basin watershed and from Whitefish Lake. A water filtration plant and Whitefish Lake pumping station were completed in November of 2000 at a total cost of over 6.2 million dollars. Financing for the project was a loan from the State Revolving Fund Program administered by the Montana Department of Environmental Quality and Montana Department of Natural Resources and Conservation.

I'm pleased to report that our drinking water is safe and meets federal and state requirements. We want our valued customers to be informed about their water utility. If you want to learn more, please attend any of our regularly scheduled City Council meetings. They are held on the first and third Monday's of each month at 7:10 PM in the City Council chambers located at Second Street and Baker Avenue.

The City of Whitefish routinely monitors for constituents in your drinking water according to Federal and State laws. The test results table on the back shows the results of **all** contaminants **detected** for the period of January 1st to December 31st, 2012. Some of our data in the tables are more than one year old, since certain chemical contaminants are monitored less than once a year. Sample dates for samples from prior years are noted in the table. Our sampling frequency complies with EPA and State drinking water regulations

In the following table you will find many terms and abbreviations you might not be familiar with. To help you better understand these terms we've provided the following definitions:

ppm: Parts per million or Milligrams per liter (mg/l) - one part per million corresponds to one minute in two years or a single penny in \$10,000.

ppb: Parts per billion or Micrograms per liter - one part per billion corresponds to one minute in 2,000 years, or a single penny in \$10,000,000.

NTU: Nephelometric Turbidity Unit - nephelometric turbidity unit is a measure of the clarity of water. Turbidity in excess of 5 NTU is just noticeable to the average person.

AL: Action Level - the concentration of a contaminant that if exceeded, triggers treatment or other requirements that a water system must follow.

TT: Treatment Technique - A treatment technique is a required process intended to reduce the level of a contaminant in drinking water.

MCL: Maximum Contaminant Level - The "Maximum Allowed" (MCL) is the highest level of a contaminant that is allowed in drinking water. MCLs are set as close to the MCLGs as feasible using the best available treatment technology.

MCLG: Maximum Contaminant Level Goal - The "Goal" (MCLG) is the level of a contaminant in drinking water below which there is no known or expected risk to health. MCLGs allow for a margin of safety.

MRDL: Maximum Residual Detection Limit - The Highest level of a disinfectant allowed in drinking water. There is convincing evidence that addition of a disinfectant is necessary for control of microbial contaminants.

MRDLG: Maximum Residual Detection Limit Goal - The level of a drinking water disinfectant below which there is no known or expected risk to health. MRDLGs do not reflect the benefits of the use of disinfectants to control microbial contaminants.

Cont.: Continuous monitoring – Instruments that monitor for the listed constituent are on-line and continuously monitor and record results.

Lead: If present, elevated levels of lead can cause serious health problems, especially for pregnant women and young children. Lead in drinking water is primarily from materials and components associated with service lines and home plumbing. The City of Whitefish is responsible for providing high quality drinking water, but cannot control the variety of materials used in plumbing components. When your water has been sitting for several hours, you can minimize the potential for lead exposure by flushing your tap for 30 seconds to 2 minutes before using water for drinking or cooking. If you are concerned about lead in your water, you may wish to have your water tested. MCL's are set at very stringent levels. To understand the possible health effects described for many regulated constituents, a person would have to drink 2 liters of water every day at the MCL level for a lifetime to have a onein-a-million chance of having the described health effect.

Some people may be more vulnerable to contaminants in drinking water than the general population. Immunocompromised persons such as persons with cancer undergoing chemotherapy, persons who have undergone organ transplants, people with HIV/AIDS or other immune system disorders, some elderly, and infants can be particularly at risk from infections.
